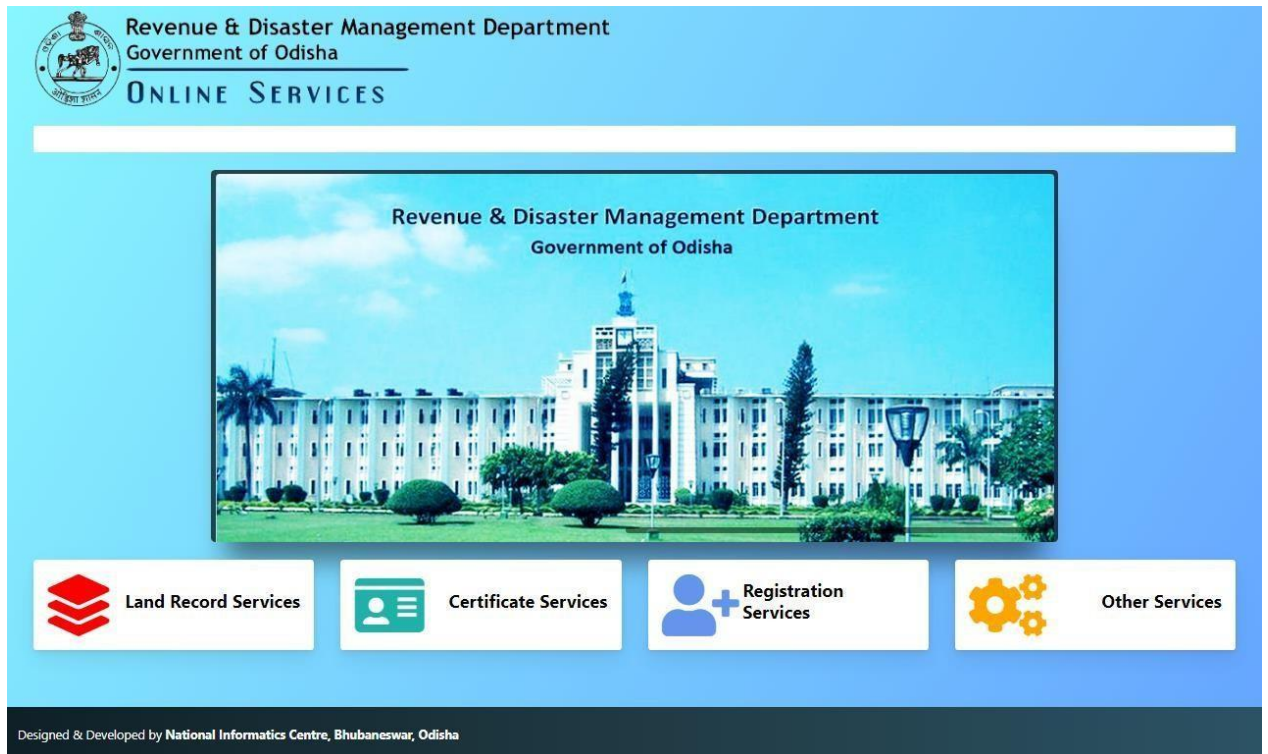


**Procedure to Apply for Section 23 A of OLR Act (Eviction of Person in Unauthorized Occupation of SC/ST Property).**
